Land Location: SW-24-37-3-W3rd


Hours: Monday to Saturday 9:00 AM - 9:00 PM

(Dawn to Dusk)

Sunday 10:00 AM - 6:00 PM

- 1. Members must wear their range cards.
- 2. All members must swipe their card upon entry and swipe it again when exiting the range even if gate is already open.
- **3.** Anyone caught using force to enter the range may result in criminal charges or loss of membership.
- **4.** One shooter must act as a range officer if there are two or more shooters on the range.
- 5. Eye and ear protection is mandatory.
- 6. PAPER TARGETS ONLY. —No humanoid likeness
- 7. All shots must be contained within the berm.
- 8. Intentional ricochets or un-aimed shots will result in loss of membership.
- 9. Consumption of alcohol before or while on the range is prohibited.
- 10.Clean up brass and targets. All brass inside the blue bins is property of the Saskatoon Wildlife Federation.
- **11.**Verbal abuse of any kind will not be tolerated and may lead to membership suspension.
- **12.**Range Safety Officers will be enforcing the rules and have the authority to issue fines and suspend range access.

Range 7 – 100m: .22LR to .308 WIN (Includes 30-06); Shotgun – slugs only *No magnum rifle calibers

Outdoor Archery Range Rules

Land Location: SE 24-37-5-W3rd

Hours: 6:00 AM - 8:00 PM (Dawn to Dusk)

May to October

- 1. Do not draw a bow back without an arrow.
- **2.** Do not dry fire (releasing the string without a nocked arrow)
- 3. No sky drawing (keep arm parallel to ground when drawing bow)
- 4. Target and field points only. No broadheads.
- 5. No crossbows
- Family members under 16 must be accompanied by an adult member.
- 7. Do not use damaged equipment.
- **8.** Avoid contact with an archer in the shooting position.
- 9. No smoking once you enter the range gate.
- **10.** It is illegal to kill, injure or fire upon wildlife (all laws enforced).
- 11. No firearms or hunting allowed. Each shooting position on the firing line has a corresponding target butt directly down-range. Each shooter must shoot only at the target provided or an approved paper target, hung on target butt.
- **12.** We reserve the right to refuse service to anyone and to inspect all bows, arrows and equipment brought to this facility.
- 13. Maximum target distance is 70 meters from the firing line.
- Please return target butts to the covered firing line when you are finished.

Indoor Archery Range Rules

Land Location: SE 24-37-5-W3rd Hours: 6:00 AM - 11:00 PM

- 1. Only target and field tips are allowed.
- 2. Only carbon, fiber, graphite, and aluminum shafts are allowed.
- 3. No homemade, fiberglass or broadhead arrows are allowed.
- 4. Target butts are for archery use only.
- 5. Maximum Bow poundage is 70 lbs. from the 25-meter line.
- 6. Cross Bows are permitted from the 25-meter line.
- No "cross-firing". All shots are to be at the target directly down range of you.
- A bow must not be partially or fully drawn back with a nocked arrow unless on the shooting line and must always be pointed down range.
- One person must act as a Range Safety Officer and ensure all shooting is managed with the typical range commands: Archers to the Line, Shoot When Ready, You May Retrieve Your Targets etc.
- 10. No shooting into walls, ceiling or anywhere other than the central area of the target butt.
- Arrows that strike the steel wall should be very carefully inspected before being re-used.
- 12. The Saskatoon Wildlife Federation is not responsible for damages to arrows which meet any of the interior structure of the building.
- 13. The Saskatoon Wildlife Federation is not responsible for damages caused by a re-used arrow that has struck any of the interior structure of the building.
- 14. Range Safety Officers will be enforcing the rules and have the authority to issue fines and suspend range access.
- a. a minimum fine of \$50 will be levied for any violation.
- a suspension or termination of your membership should it be determined by The Saskatoon Wildlife Federation Board of Directors could also occur after review of the range rule infraction.
- 15. If you witness any infractions or, structural damage that has occurred in the building, please call the office at 306 242-1666.

Indoor Rimfire Range Rules

Land Location: SE 24-37-5-W3rd Hours: 6:00 AM – 11:00 PM

- All shooters must display their membership card while using the range.
- 2. All shooters must swipe their access card upon entry and exit.
- **3.** Guests (a maximum of two) are under direct supervision of the member and must possess a valid pass.
- Only paper targets are allowed. No humanoid likeness or zombie targets are allowed.
- 5. No shotauns, black powder firearms or 17 HMR are allowed.
- **6.** No steel core bullets or any ammunition that may contain steel.
- 7. Allowed handguns and rifles 22 to 45 caliber.
- 8. Rimfire and pistol caliber rifles are allowed.
- Magnum pistol calibers are allowed be considerate of noise for fellow shooters.
- **10.** One shooter must act as a Range Officer when two or more shooters are on the range.
- 11. Eye and ear protection are mandatory.
- **12.** No smoking, alcoholic beverages, food or drinks are allowed on the range.
- 13. The ventilation system must always be used.
- 14. No steel targets are permitted.
- 15. Clean up brass and targets.
- 16. Video recording and media events are prohibited on all Saskatoon Wildlife Federation facilities unless written permission is obtained from the Board of Directors.

Firearms Safety Protocol: Applicable at All Ranges

- 1. Keep muzzles pointed downrange.
- 2. Guns must have actions open when not encased or holstered.
- 3. Guns may only be loaded at the firing line and only when ready to shoot.
- 4. If you have a jam remove the magazine, point the muzzle down range while removing the jam
- 5. Guns must not be handled behind the firing line when person(s) are downrange.
- 6. Handling of firearms is to be in a designated Safe Area along the side walls of the range
- 7. Safe Area must face the side wall.
- 8. Rifles must be upright with actions open and placed in gun racks.
- 9. Handguns must have actions open and facing side wall.
- 10. Chamber flags are recommended and available at the Office.

Archery Safety Protocol:

Applicable at All Ranges

- Always keep a loaded bow pointed down range and know what is beyond your target.
- 2. No one is allowed forward of the firing line when the line is "hot".
- 3. Never load an arrow or take an arrow out of your quiver until line is "hot".
- 4. Never use arrows that are too short for your draw length.
- 5. Do not use cracked arrows.
- **6.** Range must be declared safe before anyone goes forward of the red safety line.
- **7.** All bows must remain on racks and the line declared safe before anyone goes down-range.
- Stand to the side of the target when pulling arrows and ensure no one is behind you.
- Anyone can call an emergency "CEASE FIRE" for safety emergencies. Follow these Cease Fire Procedures:
- a. Immediately put all arrows in quivers and bows on racks / hangers.
- b. No one is allowed downrange until range is declared safe.
- c. No handling bows and/or arrows during a cease fire.

Silhouette Range Rules

Land Location: SW-10-38-4-W3rd Address: 38139 Range Road 3043

Hours: 9:00 AM - Dusk

- 1. Each member must wear their range cards.
- ONLY handgun, pistol caliber and rimfire firearms are allowed on the range. Centerfire rifles are not allowed. They will damage the reactive targets.
- 3. Do not duplicate or lend your key.
- To prevent unauthorized access, lock yourself in the range. Ensure the gate is locked when you leave.
- 5. Eye and ear protection must always be worn.
- 6. No glass or exploding targets are allowed.
- Use targets and target-stands provided. To prevent ricochets, objects are not to be placed on the ground and shot at.
- 8. The red flag attached to the flagpole must be raised while shooting and lowered when finished.
- One person must act as a Range Safety Officer if there are more than two people on the range.
- 10. All projectiles must be contained within the backstops.
- 11. All firearms must be unloaded and in a safe condition while any person is ahead of the firing line.
- 12. Shooting must be from within the red shooting boxes and all shooting positions (sitting, standing, kneeling and prone) are
- 13. There is one firing line and all shooting must cease before anyone moves forward of the firing line.
- 14. The gate will be locked, and no shooting will be allowed when farm operations are occurring on adjacent fields.
- **15.** Clean up your brass, empty hulls and garbage.
- 16. Violations will not be tolerated and may result in a suspension or loss of membership. Willful damage will be reported and may result in a suspension or loss of membership.
- 17. Consumption of alcohol or drugs, before or while on the range is strictly prohibited.
- 18. No verbal abuse will be tolerated.
